# Boarding Contract

This is a contract **between Living Prairie Kennels ("Kennel")** and the **pet owner ("Owner")** whose signature appears at the bottom of the contract. Please initial the following statements to indicate that you agree.

## PICKUP & DROP OFF

\_\_\_\_\_ All dogs **must be on-leash** when being picked up and/or dropped off.

\_\_\_\_\_ Pickup and Drop off hours are **by appointment only**. Owners must advise the Kennel ahead of time of their planned pickup / drop off times so the Kennel can ensure staff are at the office to provide service.

## KENNEL FEES & PAYMENT

\_\_\_\_\_ The Owner agrees to pay the rate of \_\_\_\_\_/day for the services of boarding the dog(s) at the Kennel.

\_\_\_\_\_ All charges incurred by Owner shall be due and payable upon pick-up of pet.

\_\_\_\_\_ The Kennel accepts payment by cash, e-transfer, and/or cheque. There is a \$50.00 fee for returned or NSF cheques. We also reserve the right to charge a \$10/day late fee on unpaid balances.

## DOG BEHAVIOR AND CARE

\_\_\_\_\_ It is the Owners responsibility to inform the Kennel of any behavior issues, habits, health issues or anything else that may impact the proper care of the dog(s) or their stay at the Kennel.

\_\_\_\_\_ The Owner is responsible to pay for any damages to the kennel facility and/or staff caused by the Owners dog(s) while the dog(s) is in our care.

\_\_\_\_\_ The Owner agrees to be solely responsible for any and all acts or behavior of your animal while it is in the care of the Kennel.

\_\_\_\_\_ The Owner understands that boarding at the kennel includes group socialization and playtime with other dogs, which could expose the dog(s) to injuries and virus/disease, and will not hold the Kennel liable.

\_\_\_\_\_ Owner represents to kennel that the pet has not been exposed to any contagious diseases (including, but not limited to: rabies, distemper, or bordetella/kennel cough) within a thirty day period prior to boarding and that it is in good health and current with all required immunizations.

\_\_\_\_\_ If any vaccines have not been administered or maintained, Owner releases Living Prairie Kennels, its staff, instructors, and agents from and against any and all liabilities, losses, damages, costs, or expenses (including medical and attorney's fees) that may occur as a result of non-administration or lapse in maintenance of vaccines and treatments of their dog.

Owner also agrees to notify Kennel of any known exposure of pet to a communicable disease and hold pet out of attending Kennel until pet is symptom free for a minimum of 30 days or with written veterinary clearance.

## VETERINARY COST AND CARE

If your pet becomes ill or injured while in care, the Kennel will take any immediate emergency action necessary for its well-being. If the Kennel is required to seek veterinary care for your animal, the Kennel will attempt to contact the Owner. In the event the Owner, emergency contact, and/or preferred veterinarian is unavailable, the Owner agrees to authorize the Kennel to transport the dog(s) to the veterinarian of our choice and authorize the veterinarian to perform any treatment/ procedure/ service the veterinarian deems medically necessary for the health and well-being of your pet. **You understand that you will be responsible for all treatment costs.**

The Owner understands and agrees the Kennel staff are not licensed veterinarians and, therefore, will not attempt to diagnose animal ailments or diseases and the Owner agrees the Kennel will not be liable for any sickness or ailment the Animal develops or manifests during their stay at the Kennel or the result of said sickness or ailment.

The Kennel highly recommends Owners carry active pet insurance to cover the cost of any medical issues. The Owner understands the Kennel is **NOT** responsible for any vet costs that occur during the dog(s) stay. All veterinary costs are the responsibility of the Owner and/or pet insurance (if applicable)

## UNCLAIMED ANIMALS

In the event an Owner has not returned to the Kennel to pick-up their dog(s) within 10 days after the scheduled pick-up date, and has not made any other arrangements for payment and/or continued boarding of the dog(s) at the Kennel, the Kennel's reserves right to surrender the dog to the appropriate rescue organization as an abandoned animal. In such a case, the Owner is still responsible for all costs incurred during the dog(s) stay at the Kennel.
