PUPPY TRAINING CONTRACT

This is a contract **between Living Prairie K9 Solutions ("Kennel")** and the **Dog Owner ("Owner")** whose signature appears at the bottom of the contract. Please initial the following statements to indicate that you agree.

PLEASE INITIAL EACH LINE TO INDICATE AGREEMENT



PICK UP & DROP OFF

_____ All dogs **must be on-leash** when being picked up and/or dropped off

Pick up and drop off times are **by appointment only during posted business hours**. Owners must advise the Kennel ahead of time of their planned pick up / drop off times so the kennel can ensure staff are at the office to provide service

TRAINING FEES AND PAYMENT

_____ The owner agrees to pay the rate of \$_____ / day for services of training the puppy at Living Prairie K9 Solutions

_____ The owner agrees to pay a deposit of \$150 to start the training service

_____ All charges incurred by owner shall be due and payable upon pick up of the puppy (minus the deposit)

_____ The Kennel accepts payment by cash, cheque, e-transfer and credit card

PUPPY BEHAVIOR AND CARE

_____ It is the owners responsibility to inform the Kennel of any behavior issues, health issues or anything else that may impact the proper care of the puppy or it's stay at the kennel

_____ The Owner is responsible to pay for any damages to the kennel facility and/or the staff caused by the Owners puppy while it is in our care

_____ The Owner agrees to be solely responsible for any and all acts or behavior of your puppy while it is in the care of the Kennel

_____ Owner represents to kennel that the puppy has not been exposed to any contagious disease (including, but not limited to: rabies, distemper, or kennel cough) within a thirty day period prior to boarding and that it is in good health and current with all required immunizations for the puppy's age or proof of titers



PLEASE INITIAL EACH LINE TO INDICATE AGREEMENT

Owner also agrees to notify Kennel of any known exposure of the puppy to a communicable disease and hold the puppy out of attending Kennel until it is symptom free for a minimum of 30 days or with written veterinary clearance

VETERINARY COST AND CARE

If your puppy becomes ill or injured while in care, the Kennel will take any immediate emergency action necessary for its well-being. If the Kennel is required to seek veterinary care for your puppy, the Kennel will attempt to contact the owner. In the event the Owner, emergency contact, and/or preferred veterinarian is unavailable, the Owner agrees to authorize the Kennel to transport the puppy to the veterinarian of our choice and authorize the veterinarian to perform any treatment/ procedure/ service the veterinarian deems medically necessary for the health and well-being of your puppy. **You understand that you will be responsible for all treatment costs.**

The Owner understands and agrees the Kennel staff are not licensed veterinarians and, therefore, will not attempt to diagnose the puppy's ailments or disease and the Owner agrees the Kennel will not be liable for any sickness or ailment the puppy develops or manifests during their stay at the Kennel or the result of said sickness or ailment

UNCLAIMED DOGS

In the event an Owner has not returned to the Kennel to pick up their puppy within 10 days after the scheduled pick up date, and has not made any other arrangements for payment and/or continued boarding of the puppy at the Kennel, the Kennel reserves right to surrender the puppy to the appropriate rescue organization as an abandoned dog. In such a case, the Owner is still responsible for all costs incurred during the puppy's stay at the Kennel

.ACKNOWLEDGMENT OF RISK AND RELEASE

The owner understands and acknowledges that despite Kennel's effort to maintain the health and safety of all pets, there are certain risks involved in all dog boarding/ training and daycare facilities. These risks include but are not limited to dogs being injured during an altercation with another dog, contracting lice/mites, kennel cough or some other communicable illness, injury due to escape attempts, and self administered injuries arising from anxiety or fear. The Owner understands, and voluntarily accepts the risks, and hereby releases the Kennel and its staff and volunteers from any and all claims arising out of such injury or illness. The Owner will be responsible for their dog's veterinary bills or any other costs related to such injury or illness. The Owner further understands and agrees that if their dog attacks and injures another dog (ie. an altercation between dogs that is one-sided and the Owner's dog is at fault), the Owner will be responsible for paying for any damage caused to that dog and/or its owners.

PLEASE INITIAL EACH LINE TO INDICATE AGREEMENT

Puppy Boot Camp

_____ \$ 55/day **BASIC TRAINING * REQUIRED:** daily boarding fee, crate training, sleeping through the night, start with house training, socializing with people and suitable dogs and bite inhibition

_____ \$10/day **LEASH WALKING:** train your puppy to walk calmly and politely on a leash without pulling

_____ \$10/day **GROOMING:** teach your puppy to allow brushing, nail clipping and baths without fussing

_____ \$10/day **TRAVELING:** let your puppy become accustomed to riding in a vehicle in a crate or buckled in the seat

_____ \$10/day **BASIC OBEDIENCE:** important skills like SIT, DOWN, WAIT, RECALL

_____ \$10/day **STROLLER/WALKER:** teach your puppy to walk calmly beside a stroller or walker

JUNIOR ACADEMY \$85/DAY includes:

- Daily boarding fee
- Socializing with other suitable and safe dogs
- Daily pack walks and playtime
- No jumping up
- Leash walking
- Basic obedience (sit, down, stay)
- Basic manners (sit to put on and take off leash, sit before eating, sit before going through doors)

CONTINUE WITH TRAINING ONCE THE PUPPY COMES HOME

_____ The owner agrees to continue with the puppy's training schedule as recommended by the Kennel (trainer) to insure lasting results. If the schedule is not being followed, the Kennel (trainer) is not responsible for old habits to reappear.
